
Williams v. California Anniversary Outreach Campaign: Find the Notice in Your Classroom

Throughout 2025, Clean Air Allies will be doing an outreach campaign to celebrate the anniversary of *Williams v. California*, a lawsuit brought in 2000 by Eliezer Williams and nearly 100 other California schoolchildren arguing for better school conditions as a matter of state constitutional right.

The campaign will explore the *Williams* case and its legacy as they relate to accountability around California public school facilities conditions in general and IAQ in particular.

We're inviting California adult family members, teachers, school employees, community members, and students age 13+ to know their rights by looking for Williams Notices in their non-charter public school classrooms. And if they can, report their findings and share their notice photos with us.

New School IAQ-Related California Bill: AB 832

On February 19, AB 832 was introduced by California Assemblymember Al Muratsuchi. If passed by the Legislature and signed into law by Governor Newsom, the bill would extend by 4 years the operation of the California Schools Healthy Air, Plumbing, and Efficiency (CalSHAPE) Program, which is currently set to wind down in late 2026. According to public records obtained from the California Energy Commission (CEC), which administers CalSHAPE, in December 2024, approximately \$190 million remained in the CalSHAPE fund.

In recent years, CalSHAPE has been the most significant source of state-level funding for school IAQ assessments and HVAC maintenance, repairs, and upgrades. As part of our California Alliance for Clean Air in Schools initiative, Clean Air Allies has been involved in outreach to encourage school districts to apply for CalSHAPE and in advocacy to make sure the monies collected in the CalSHAPE fund go out to schools.

In fall 2024, we joined with other stakeholders to defeat AB 3121, which would have raided CalSHAPE monies for a small utility ratepayer credit. As a result of that effort, approximately

\$170 million went out to school districts whose applications for grant awards for IAQ assessments and HVAC work had been frozen.

AB 832 also contains a cursory section related to potential school IAQ "standards, guidelines, and recommendations," but there are questions about what this would mean in practice and whether it is politically viable.

Clean Air Allies is in communication with Assemblymember Muratsuchi's office and other statelevel stakeholders. Please watch out for future updates.

Featured School IAQ Resources

Free IAQ Video Lessons from UC Davis and CDPH

The University of California, Davis College of Engineering and the California Department of Public Health (CDPH) have collaborated to create thirty-one free video lessons covering a wide variety of IAQ topics, ranging from IAQ basics to IAQ threats like infectious pathogens and wildfire smoke to IAQ assessment and improvement technologies. The lessons are presented by UC Davis IAQ experts Richard Corsi, Chris Cappa, and Theresa Pistochini. While designed for facilities managers, they also are of interest to members of the general public who care about IAQ.

California IAQ Guidance for Schools

In Q4 2024, California agencies put out two sets of school IAQ-related guidance.

In October, the California Department of Education (CDE), along with the California Department of Public Health (CDPH) and the California Air Resources Board (CARB), released "Guidelines for Schools and Wildfire Smoke." This updated guidance states that "All children are considered sensitive to the health effects of air pollution because their lungs and immune systems are still developing" and includes new Air Quality Index (AQI)-based outdoor activity limitation thresholds.

CDPH also issued updated "Improving Indoor Air Quality in Schools" guidance in November 2024. In it, CDPH "recommends providing a minimum of at least 5 air changes per hour or 30 cfm/occupant of equivalent clean airflow, whichever is greater, in occupied classroom environments."

Both documents include resources and strategies to help schools follow the guidance.
